

### I. FOOD AND BEVERAGE SECTOR

### → National Consultative Meeting on the EAC Fruits and Vegetables Strategy, 2021 - 2031



### **Engagement Details**

KAM participated in the national consultative meeting to update and monitor progress in the implementation of the EAC Fruits and Vegetables Strategy, which seeks to enhance the development of the agriculture sector through regional agro-processing and value addition. The meeting also aimed to validate draft reports on the EAC Guidelines for Seed Potato Release and Registration, as well as the Strategic Action Plan for promoting value addition and trade in the EAC nuts value chain.

#### Outcome

Finalization and adoption of the reports on the Guidelines for Seed Potato Release and Registration, as well as the Strategic Action Plan for the EAC nuts value chain.

### → KRA and Weights & Measure Inspection visit to Micro-Craft Distillery (Yamaroku Ltd)



### **Engagement Details**

On 19th July 2024, the Kenya Revenue Authority (KRA) and the Weights and Measures Department visited Yamaroku Limited, a micro-craft distillery producing rum. The visit aimed to inform the development of an alternative excise duty framework for this segment of alcoholic beverage manufacturers, with the goal of facilitating their operations and addressing the challenges micro-craft distilleries face in complying with current regulatory requirements.

#### **Outcome**

- I.Micro-craft distilleries are to re-apply for the relevant approvals in accordance with the directives issued on 6th March 2024 by the Ministry of Interior, before inviting KRA and the Weights and Measures Department for final approval to facilitate short-term production.
- 2.KRA to finalize the development of the alternative regulatory framework within 6 months.

### → Quarter 2 Sector Meeting



#### **Engagement Details**

The agro-processing, food, and beverages sector held its Q2 meeting on 23rd July 2024. The main focus areas of the meeting were the outcome of the EAC 2024 budget, finalization of the sector's position on the proposal to amend the standard for labeling pre-packaged foods (EAS 38), and the process for transitioning sector leadership.

#### **Outcome**

- I. Subsector meetings will be convened for the beverages and baked products industries.
- 2. Support will be provided to the meat subsector, particularly regarding the US-Kenya Strategic Trade and Investment Partnership (STIP) and county levy charges.

### → Provision of Sanitary Towels Bill, 2024




### **Engagement Details**

#### **Outcome**

The Sub-sector's position was compiled and submitted to the Senate for consideration prior to the passage of the Bill.

#### → EAC Gazette Notice



#### Tax Head

On 4th July 2024, a KAM Trade and Tax Committee (TTC) meeting was held to discuss the outcomes of the EAC Gazette published on 30th June 2024. The impact of duties on the Paper Sector was examined and documented for advocacy purposes.

#### **Outcome**

The TTC recommended revoking the Stay of Application for the EAC CET to apply a lower duty rate, in line with the Paper Verification Report. This resolution was submitted to the National Treasury for further guidance.

### 7. CHEMICAL & ALLIED SECTOR

### → Chemical & Allied Sector Quarter 2 Meeting



### **Engagement Details**

The Chemical and Allied Sector held its Q2 meeting on 9th July 2024, where discussions focused on the TTC ruling on edible oil, the EAC budget outcome, and the status of the Finance Bill 2024.

#### **Outcome**

All TTC rulings will be circulated to members, and feedback from the EAC Gazette will be escalated to the National Treasury.

### → Establishment of the Cosmetics Subsector Kitty



### **Engagement Details**

A meeting was held with the Cosmetics Subsector leadership to discuss various challenges, including regulation by the Pharmacy and Poisons Board, the National Drugs Authority Bill in Uganda, and KEBS standards for cosmetic products.

#### **Outcome**

Establish a Cosmetics Sub-sector fund to address emerging issues that may require budgetary support, such as hosting parliamentarians and funding travel to the EAC, among other needs.

### 8. METAL AND ALLIED SECTOR

### → Metal and Allied Sector Quarter 2 Meeting

### **Engagement Details**

The Metal and Allied Sector held its Q2 meeting on 22nd July 2024, where discussions focused on the Special Operating Framework Agreement (SOFA) and sector governance.

#### **Outcome**

- 1.lt was agreed that SOFA should be removed as it unfairly benefits only one industry, excluding others from the incentive.
- 2. The sector and sub-sector leadership will continue their oversight roles until the sector decides on any changes.

### → TTC engages SOFA Beneficiary

### **Engagement Details**

Johnson attended a meeting hosted by the Trade and Tax Committee with SOFA beneficiaries. The meeting aimed to clarify how SOFA operates, its legal aspects, and its the KAM Secretariat. impact on the steel sector. This discussion followed concerns raised by the steel sector players regarding the issuance of incentives to a single company.

#### Outcome

On 18th July 2024, Sector Chair Mr. Bobby A sector meeting will be convened to present the position of the SOFA beneficiary for a sector-wide decision. The beneficiary is to disclose the agreement to

A meeting was held with Friendship Containers Limited on 5th July 2024 to challenges facing food manufacturers. Key issues included amending the tariff code 7310.29.20 description to specify beverage cans and addressing duty remission for lacquers.

#### Outcome

- 1. Friendship Containers Limited will provide a brief on their challenges in preparation for the upcoming EAC verification mission for food cans.
- 2.A meeting will be held with the Chemical Sector to confirm availability of food-grade lacquers.

### 9. TIMBER AND FURNITURE SECTOR

### → Quarterly Sector Meeting



### **Engagement Details**

A quarterly sector meeting was held on 10th July 2024, where the discussion focused on the budget outcome and emerging opportunities from AfCFTA and the Tripartite Free Trade Area (TFTA).

#### **Outcome**

Feedback on the budget outcome will be submitted to the National Treasury for consideration. The KAM Secretariat will organize a sector-specific session on trade opportunities under AfCFTA, and members have been encouraged to stay alert for further details.

### → Sector and Ashut Plastics plant 1,400 seedlings at Kinale Forest Station



### **Engagement Details**

On 5th July 2024, members of the Timber and Furniture Sector, in collaboration with Ashut Plastics, participated in a tree planting event at Kinale Forest Station's Barika Block. Together with the Kenya Forest Service, they planted 1,400 seedlings.

### **Outcome**

Ongoing efforts are focused on encouraging more members to contribute to the forest fund and adopt a forest. Members have the flexibility to choose a forest to adopt anywhere in the country based on their business preferences.

### → Emerging issues following EAC Gazette Notice



### **Engagement Details**

During the sector meeting, it was reported that MDF with a thickness of less than 5mm was assigned a duty rate of 35% plus a specific duty. Since this product is not manufactured locally, members requested that duty remission be granted to local manufacturers.

### **Outcome**

The product will be resubmitted to the National Treasury as part of the feedback for consideration during the budget process.

#### **Upcoming Activities:**

I.A sector-specific training for the timber industry on AfCFTA and TFTA will be organized to promote the export of furniture from Kenya. The date will be confirmed.

### 10. BUILDING, MINING AND CONSTRUCTION SECTOR

### → Quarter 2 Sector Meeting



### **Engagement Details**

The quarterly sector meeting was held on 8th July 2024, where discussions included the EAC budget outcome, demand notices for outstanding royalties issued to quarry members, emerging sector issues, and updates on various engagements with government agencies.

#### **Outcome**

Feedback on the budget outcome will be submitted to the National Treasury for consideration. The KAM Secretariat will follow up on pending and emerging actions.

### → KAM engagement with KEBS MD



### **Engagement Details**

On 19th July 2024, the KAM Cement Subsector met with KEBS MD, Ms. Esther Ngari, to discuss the performance of cement products for the period 2023-2024. The discussion emphasized the need for the Subsector to adhere to established standards to achieve and maintain full compliance.

#### **Outcome**

KEBS will continuously collaborate with the industry, conduct regular market surveillance, involve other government agencies to address widespread cement adulteration, and perform round-robin testing, among other interventions, to ensure the cement industry achieves 100% compliance.

#### → Cement Subsector Meets



#### **Engagement Details**

On 19th July 2024, the Cement Subsector held a meeting to review the detailed Subsector report. Discussions covered specific issues including changes in mining royalties, cement bag recyclability, high power costs, and quality concerns, among others.

#### Outcome

The KAM Secretariat will follow up on action items, including engaging Kenya Power and Lighting Company (KPLC), Kenya Electricity Transmission Company (KETRACO), and Kenya Electricity Generating Company (KenGen) to resolve long-standing power challenges.

#### **Upcoming Activities:**

I. A sector meeting will be held to provide specific training on opportunities under the AfCFTA and TFTA. 2. Cement Subsector meeting to be held on 6th September 2024 at 3:00 pm.

### II. SALT SUB-SECTOR

### Salt Sub-sector engages Stakeholders on Boundary Marking

### **Engagement Details**

### **Outcome**



On 2nd July 2024, Magarini DCC, Mr. Peter Thiong'o, together with Adu Ward Member of the County Assembly (MCA) Zia Kahindi, chaired a meeting with Magarini Sub County stakeholders on land matters. Present were the Sub County Surveyor, a representative from the National Land Commission (NLC), and Kilifi County Surveyors. The meeting focused on boundary identification and marking for Kensalt Kanagoni land.

The meeting requested the County to halt any further allocations or surveying of the land and maintain the status quo until a verification survey is completed. Meanwhile, Kensalt will visit the land registrar in Mombasa to obtain the necessary documents to guide the next meeting.

### → Salt Sub-sector engages KEPRO

### **Engagement Details**

### **Outcome**



On 9th July 2024, Salt Sub-sector members met with KEPRO to discuss the Extended Producer Responsibility (EPR) fees for the sector. KEPRO CEO James Odongo praised the Sub-sector for its commitment to responsible management waste highlighted that high monthly declaration fees, due to NEMA requirements and waste recycling value chain handlers, pose a significant challenge.

A high-level follow-up meeting with KEPRO will be arranged to explore options for reducing the fees. The Sub-sector will also propose alternative solutions to KEPRO, such as taking on responsibilities like waste management awareness, environmental messaging on packaging, and providing collection points.

### → Salt Sub-sector participates in Magarini Mangrove Resource Marking

## **Engagement Details**

### On 10th July 2024, the Salt Sub-sector participated in a Kenya Forest Service (KFS) meeting with the Magarini Community Forest Association on mangrove resource identification. Stakeholders and community members engaged in focus group discussions to map existing and potential resources in the mangrove and marine ecosystem.

### **Outcome**

The team identified both existing and previously unidentified resources within the mangrove forest ecosystem and developed a resource map to guide the utilization, management, and conservation of the mangrove forest.

On 17th July 2024, the Salt Sub-sector members participated in the Kilifi County Engagement Forum on peace and security matters. The forum gathered various stakeholders to discuss and address peace and security issues within the County, aiming to enhance overall safety and promote sustainable development.

The Kilifi County Action Plan (K-CAP) on Preventing and Countering Violent Extremism (PCVE) was reviewed, and an implementation status report was presented to stakeholders.

### → Salt Sub-sector meets State Department for Industry

### **Engagement Details**

#### Outcome



On 18th July 2024, Salt Sub-sector members met with the State Department for Industry to address key challenges affecting the industry. They highlighted issues impacting competitiveness, including sea water charges, mining export levies, duty remission for salt imports by EAC Partner States, the Mining Act of 2016, and overlapping regulatory frameworks.

During the meeting, both parties agreed to collaborate on resolving these challenges and to pursue joint ministerial engagement to address cross-cutting and overlapping issues.

On 29th and 31st July 2024, the Salt Subsector took part in a two-day Participatory Forest Management Plan (PFMP) workshop at Arabuko Jamii Villas, Mida. The workshop finalized the PFMP draft, addressed stakeholder concerns, and prepared for the PFMP validation process.

The workshop reviewed and finalized the Magarini Participatory Forest Management Plan (PFMP) and scheduled its validation.
