# Chairman's Message

The Central Chapter has been on the forefront in advocating for membership issues that keep arising.

Top on our list is the inter-county trade issue, which has not only affected manufacturers in the county, but proven to be a major bottleneck for the ease of doing business in the entire country.



The Council of Governors has taken up the issue and even though they may appear to be taking a little bit longer to resolve it, the matter is picking pace. Key priority issues are; Trade, fees and charges, infrastructure, and physical planning.

The Association's Membership Help Desk (MHD) has recorded a surge in the number of impounded delivery vehicles. As such, we wish to reiterate the following key pointers to our members:

- If you engage transporters (with a delivery note) in supplying manufactured goods to your distributors, they don't require the distribution license. The distributor receiving the goods does. This therefore means that your goods shouldn't be impounded.
- There have been reports of rogue county enforcement officers harassing distributors. If possible, verify the authenticity of the officer engaging your vehicle.
- If your company is engaged in distribution, they require a distribution license. Each vehicle should have a copy of the license, which they produce to the enforcement officers. The best strategy is to zone-off your distribution network, so that only certain vehicles operate in specific areas.

- Branding fees vary within the different counties. Due diligence is required while visiting new markets. Contact the chapter office if you are unsure about any of regulatory issues.
- Once your vehicle is impounded, contact the Chapter Officer ASAP. Do not issue bribes.
