#### → Edible oil subsector meeting with PS Treasury and PS Industry



#### **Engagement Details**

On 3rd October 2024, the Edible Oil PS Treasury to convene a meeting with the Subsector held a meeting with the Principal Secretary of Treasury, Dr. Chris Kiptoo, and discuss the matter and present the facts the Principal Secretary of Industry, Dr. Juma shared by the industry with a view to agree Mukhwana, to voice their concerns regarding the 10% import duty on crude palm oil (CPO) imposed through a stay of application in the EAC Gazette dated 30th June 2024. The meeting also explored potential interventions to support the industry and identified areas to enhance collaboration between processors and regulators.

#### Outcome

# **Engagement Details**

On October 3rd, 2024, KAM participated in a high-level stakeholder engagement with H.E President William Ruto to discuss opportunities available for players in the building and construction sector and how to leverage them. During the meeting, KAM highlighted its strong capacity to supply a wide range of housing and construction materials, showcasing its potential to support large-scale housing projects with locally sourced products.

#### Outcome

A contractual framework will be developed to ensure transparency within the system and facilitate the monitoring of local sourcing.

# → Building. mining and construction Q3 meeting



#### **Engagement Details**

On October 25th, 2024, the KAM Building, Mining, and Construction Sector held its Q3 meeting to discuss current challenges facing the sector and receive updates on ongoing engagements with government agencies. Key topics included the validation of the sector's FY 2025/26 budget proposals and the impact of new regulations, including those related to mining.

#### **Outcome**

It was agreed to enhance the justification of the flagged budget proposals and to seek engagement with various government agencies to discuss the challenges facing the sector and identify solutions to address them.

#### → KAM cement sub-Sector players engage CS, PS Mining



#### **Engagement Details**

On October 29th, 2024, KAM engaged with Hon. Hassan Ali Joho, Cabinet Secretary for the Ministry of Mining, Blue Economy, and Maritime Affairs, to discuss collaborative strategies aimed at enhancing the mining sector's contribution to Kenya's industrial growth. The discussions focused on addressing key industry challenges, promoting sustainable practices, and exploring solutions. Key topics included mining licenses, regulations, the impact of the new mining regulations on the cement sub-sector, and the rehabilitation and restoration of quarries.

#### Outcome

- I. Manufacturers to adhere to established laws and regulations governing mining activities.
- 2.A continuous dialogue with stakeholders will be maintained to address emerging issues. Additionally, the sub-sector will write to the ministry for clarification on any ambiguous areas within the act and regulations.

#### → Engagement with PS State Department for Industry



#### **Engagement Details**

On 3rd October 2024, the Plastics Sector held a meeting with the State Department for Industry to explore potential areas of collaboration and intervention. The sector identified key priorities for collaboration, including the implementation of Extended Producer Responsibility (EPR) schemes, VAT relief for recycling plants and machinery, public participation in the EAC Single-Use Plastics Bill, and opposition to the introduction of an eco-levy by the Ministry of Environment.

#### **Outcome**

- I.SDI committed to supporting the sector in the budget proposals process, providing incentives for recycling plants and machinery.
- 2.SDI will liaise with the Ministry of EAC on the status of the EAC Single-Use Plastics Bill and the Ministry of Environment on the eco-levy and EPR regulations.

# → KAM, plastics & rubber sector meeting on EAC single use plastics bill, 2024



#### **Engagement Details**

On October 22nd, the Plastics & Rubber Sector convened a meeting to discuss the Single-Use proposed EAC Plastics (Prohibition of Manufacturing, Importation, Use, and Sale) Bill, 2024. The bill seeks to ban the production, importation, and sale of single-use plastics across the EAC, including Kenya. Manufacturers submitted their comments opposing the bill, emphasizing Kenya's ongoing investments commitment to implementing Extended Producer Responsibility (EPR) schemes instead.

#### **Outcome**

Manufacturers adopted an advocacy strategy to engage stakeholders on the impact of the proposed EAC Bill, promote the adoption of EPR schemes at the EAC level, and ensure alignment of the bill with ongoing discussions under the Global Plastics Treaty, in which Kenya is a participant.
