# **Background**

**Kenya National Chamber of Commerce and Industry** serves as a unified platform for exporters, supporting businesses in navigating the export process, compliance procedures and market expansion. To enhance accessibility to export information and streamline documentation, it is implementing an **Al-powered Export Support Platform**.

#### **Objectives**

The primary objective of this initiative is to develop and deploy a technology-driven solution that:

Provides seamless access to export procedures, documentation requirements and compliance guidelines.

Connects exporters with **global market opportunities**, including potential buyers and trade networks.

Offers real-time regulatory updates and expert support to ensure compliance.

Supports businesses with trade finance options and market research insights.

Enhances efficiency by automating key processes in the export journey.

### **Scope of Work**

The service provider shall be responsible for the development, deployment and maintenance of an Al-powered export support platform with the following features:

#### I. Market Access & Research

Putting together different documentations from partner organizations.

Getting access to data of verified buyers, importers, and trade networks.

Getting access to data of trade shows and event notifications relevant to exporters.

#### 2. Export Documentation & Compliance

Step-by-step guidance on **export procedures and documentation**.

Access to compliance forms, including export permits and certificates of origin.

Automated regulatory updates to ensure businesses comply with evolving standards.

#### 3. Al-powered Assistance & Support

Web-based chatbot, WhatsApp and or App integration for 24/7 support.





Multilingual capabilities for broader accessibility.

Expert guidance and a query resolution system.

### 4. Technology & System Integration

Development and setup of the Al-driven platform dashboard for the admin.

Training of the Ai Model.

Fine tuning of the model to be as natural language and polished information as possible.

Integration with KNCCI's existing digital infrastructure (if applicable).

Designing the chat platform accessed on WhatsApp or web app.

Customizing of ai mini-crm to help access client sentiments and chat analysis.

Reports done graphically on the member chats.

Ability to have Ai recommendations.

Ability to do sentimental analysis of the chats from members.

Implementation of security measures, including penetration testing and server setup.

#### **Deliverables**

- ❖ Fully operational Al-powered Export Support Platform accessible to the members via web and WhatsApp.
- \* Training sessions for KNCCI staff on system management and customer engagement.
- ❖ Data analytics dashboard to track user engagement and export trends.
- ❖ Technical support & system maintenance plan post-deployment.
