→ Meeting with State Department of Industry on utilization of local sugar for industry

Engagement Details

On Thursday 13th February 2025, KAM participated in a Stakeholder Consultation Meeting convened by the State Department for Industrialization to discuss utilization of locally processed sugar for industrial processes. The meeting was attended by other stakeholders including Kenya Sugar Millers Association (KESMA) and Kenya Sugar Board (KSB).

Outcome

- I.Kenya to continue accessing the Duty Remission Scheme on sugar for industrial use.
- 2.A roadmap of 5 years to improve Kenya's sugar production will be developed.
- 3. Stakeholders to participate in the consultation forums on the Draft Sugar Industry Regulations.
- 4. Sugar millers are to submit their proposals for the review of the Rules of Origin for raw sugar to the Ministry of Trade, Investment, and Industry.

A key concern for the sub-sector was the excise duty on glass, which was successfully resolved.

KAM will propose specific tariff codes 7007.19 and 7007.29 to be subject to excise duty instead of the entire chapter.

Stone coated roofing tiles and Al Zinc manufacturers meeting



Engagement Details

stone-coated roofing tiles and Al-Zinc steel coils held a meeting to discuss a budget coil under Chapter 7210.61.00, highlighting proposal requesting duty remission on Althe lack of local production of 1,390 mm Zinc steel coil under Chapter 7210.61.00. The justification for the request was that steel coils with a width of 1,390 mm are not manufactured locally, making them a crucial input for the production of stone-coated roofing tiles.

Outcome

On 20th February 2025, manufacturers of Manufacturers agreed to submit a formal request for duty remission on Al-Zinc steel steel coils as a key justification.

Meeting on policy interventions for a competitive Steel Industry





On 12th February 2025, the sector officer supported Krystalline Salt Company during a meeting with community opinion leaders and two Members of the County Assembly. The meeting brought together the Members of the County Assembly for Adu Ward and Gongoni Ward, along with community opinion leaders, to strategize on actions to address the seawater charges imposed by the Water Resources Authority on salt extraction, in order to prevent the closure of salt companies.

Outcome

- I. The meeting addressed several issues raised by the leaders that needed to be resolved to strengthen the company's relationship with the community.
- 2.A committee was formed to draft a petition, which will be presented to the President by either the area Member of Parliament or the County Governor.

Meeting with Kilifi County Deputy Governor



Engagement Details

On 13th February 2025, Kenya Association of Manufacturers (KAM) Coast Chapter members held a meeting with the Deputy Governor of Kilifi County to discuss multiple county levies. The KAM Devolution Chair, Rashid Mohamed highlighted manufacturers were already paying several levies to the county and viewed the offloading levy as an additional and unnecessary financial burden. He emphasized that this levy was traditionally charged at the market rather than at business premises and encouraged collaboration to resolve the issue amicably instead of resorting to litigation.

Outcome

- I.The County assured stakeholders of its open-door policy and encouraged continuous dialogue to address grievances and suggestions.
- 2. It was agreed that offloading fees would not be applied to businesses with a valid Single Business Permit (SBP), and the collection of this levy would be halted with immediate effect.

Salt sub sector meeting with Kenya Power



Engagement Details

On 19th February 2025, the Salt Sub-sector held a meeting with the Kenya Power Malindi team to discuss power challenges along the Salt Belt area. The meeting, chaired by the Regional Commercial Manager, Moses Werunga was attended by the Sub-County Kenya Power and Lighting Company (KPLC) team and Salt Sub-sector members. Key issues discussed included power fluctuations, frequent outages, and KPLC's plans to address these challenges. The persistent power issues in the Salt Belt area were significantly affecting salt production.

→ Petroleum, Oil, Gas and Lubricants Sub-sector Quarter | Meeting



Engagement Details

On 21st February 2025, the Petroleum, Oil, Gas & Lubricants Sub-sector held its Q1 meeting to discuss the importation and manufacture of greases, pre-shipment versus destination inspection for petroleum products, and the Kenya Revenue Authority (KRA) tariff classification on white oils. Members deliberated on the Kenya Bureau of Standards (KEBS) requirements for greases, emphasizing that they should have a dropping point of 180°C and preferably be made from lithium.

Outcome

- I. Members agreed to develop a white paper proposing the implementation of pre-shipment inspection for petroleum products.
- 2. Manufacturers committed to enforcing standards for greases and requested enhanced market surveillance on both imported and locally manufactured products.
- 3.KAM Secretariat will convene a multistakeholder meeting to address the rise in counterfeits and substandard products.

→ Transformer Manufacturers meeting on excise duty for imported transformers



Engagement Details

On 18th February 2025, transformer manufacturers held a meeting to discuss the introduction of excise duty. Manufacturers noted that the importation of transformers with ratings above 2500kVA should not be a major concern, as these are imported based on project needs, primarily funded by the Government of Kenya. Additionally, manufacturers welcomed the excise duty and advocated for local sourcing of transformers by power utility firms in Kenya to support the growth of the industry.

Outcome

- I.Manufacturers appreciated the government's support through the provision of duty remission for raw materials and inputs used in manufacturing transformers, as well as the introduction of excise duty.
- 2. Transformer manufacturers requested a meeting with power and energy generation firms in the country to discuss local sourcing under government infrastructure projects.


Engagement Details


