

TERMS OF REFERENCE (TOR) KAM'S E-LEARNING PLATFORM

Background:

The Kenya Association of Manufacturers (KAM) is a dynamic, vibrant, credible, and respected Business Membership Organization serving as the representative value-add manufacturing industries in Kenya and serve as a common voice for manufacturing and other value add sectors in Kenya. Assignment's Objective:

The objective of this engagement is to select a reputable organization that will assist KAM develop and install an e-learning platform to deliver highly interactive online/virtual training programs for KAM to enhance increased training accessibility and improved cost-efficiency.

The platform should be user-friendly, scalable, and capable of supporting a wide range of training content, delivery formats, a post-course evaluation and certification for learners to complete once they finish the training.

Scope of Work:

Platform Selection and Implementation:

- Based on evaluation of KAM's specific requirements and budget develop a suitable fully functional cloud-based e-learning platform customized to KAM's specified requirements ensuring seamless integration with existing systems.
- Provide comprehensive training and support to KAM's staff on platform usage and administration.

Course Development and Hosting:

- Collaborate with KAM's training team to develop and upload training courses onto the platform.
- Ensure that the platform can accommodate various content formats, including videos, presentations, session quizzes/exercises, and interactive exercises.
- Provide technical support for course development and maintenance.

Learner Management and Tracking:

- Manage learner enrolment and registration.
- Track learner progress, completion rates, and performance metrics.
- Enable online/digital evaluation, approval and certification

Fully Virtual Classroom Functionality:

- Provide an interactive virtual classroom environment with features such as live streaming, video conferencing, group breakout sessions, chat, and screen sharing.
- Provide through the platform an effective real-time interaction between trainers and learners.

Technical Support and Maintenance:

- Provide ongoing technical support and maintenance to relevant KAM staff on the e- learning platform.
- Ensure platform uptime and reliability.
- Address any technical issues or bugs promptly.
- Develop the platform's security structures and updates.

Key Requirements

- User-Friendly Interface: The platform should be intuitive and easy to navigate for both learners and trainers.
- **Scalability:** The platform should scale to accommodate a growing number of learners and courses.
- **Customizability:** The platform should allow for customization of branding, course layouts, and reporting features.
- Integration Capabilities: The platform should integrate seamlessly with KAM's existing systems (e.g., HRIS, LMS) and include compatibility with the Mobile phone (Android and IOS).
- **Security and Privacy:** The platform should adhere to strict security and privacy standards to protect learner data.
- Accessibility: The platform should be accessible to learners with disabilities.
- **Platform Capabilities:** The platform should enable administering of quizzes and end of program exam and certification i.e. to move from stage/level to another and upon completion of the course program respectively.

- f) CR-12 Certificate of respective country
- g) Valid Tax Compliance certificate of respective country
- h) Testimonials from at least ONE organization that you have already installed a similar elearning platform
- i) Financial proposal indicating proposed fee and any additional associated costs if any.

Timeline:

The e-learning platform is scheduled to be in place before end of June 2025 (4 months period). Submissions will be evaluated on a Rolling basis and the final **Deadline** for any submission is **Friday**, **28**th **March**, **2025**.

- **Methodology and Approach:** The suitability, customization and features of the elearning platform and approach in meeting the objectives of installing the platform.
- **Timeliness:** The proposed timeline for assignment delivery, ensuring it aligns with specified requirements.

- **Statutory Certification:** Possession of all specified statutory certifications required to deliver this assignment.
- **Financial Proposal:** The financial proposal's competitiveness and alignment with the budget for the development and installation of the e-learning platform.
