FOOD & BEVERAGE SECTOR

→ Biscuits Sub-sector Meeting



Engagement Details

The Biscuits Sub-Sector met on 26th March 2025 to discuss emerging industry issues. Key issues discussed during the meeting include concerns pertaining to the SM requirement following the gazettment of EAS 781:2024 which is the new Biscuits - Specification (Second edition).1. The new Standard specifies requirements, sampling and test methods for biscuits intended for human consumption. It was noted that the standard has introduced types and categories of biscuits as follows:
1. Type of biscuits: Plain, Filled, Coated, Cream
2. Category of biscuits: Crackers & Wafers.

Outcome

- 2.Members to bring to the attention of KAM any challenges faced with SM permit renewals
- 3.KAM to convene a sensitization forum with KEBS in case of any challenges
- 4.Sub-sector Lead to convene follow-up meeting

→ Dairy Sub-sector Meeting



Engagement Details

On 6th March 2025, the Sub-sector members met to discuss the following key issues:

Fiscal & Regulatory Challenges

- Fruit Pulp Imports: High costs due to permits/levies on imports from COMESA (despite duty-free status) are burdening manufacturers.
- Antibiotic Testing Kits: High duties on these kits are compromising milk safety by making quality assurance unaffordable.

EPR Regulations

- Concerns over unclear fees for imported packaging (undefined "item" classification).

Outcome

1. Members to submit budget proposals on fruit pulps and antibiotic testing kits for the next budget cycle
- 2.KAM and Dairy Sub-sector leadership to convene a physical meeting with dairy processors to strengthen sector participation under KAM
- 3.KAM to circulate questionnaire to members for review and consideration ahead of the next meeting
4. Bio Foods to support in convening sensitization forum for sector players on EPR Regulations

→Bus Body Building Sub-sector Members Q1 Meeting



Engagement Details

On 3rd March 2025, the Bus Body Building Sub-sector members held a meeting and the following key issues were discussed: New leadership vision for the sub sector, 2025 Proposed New Rules for School Buses, Compliance with KS372 Standards & key industry Policy updates:

- Legal Notice 84 (LN 84)
- Automotive Bill 2023

7. Status of local supply of paper packaging material and PPB challenges

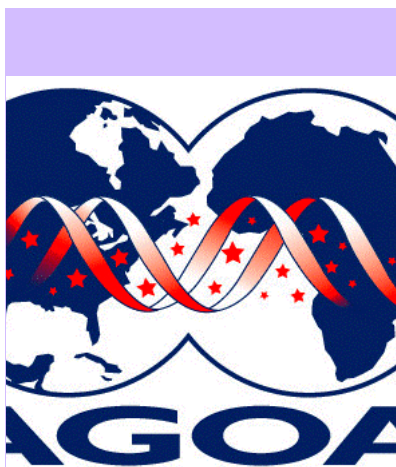
Outcome

During the meeting, Mr. Pankaj Bedi and Mr. Thomas Pthoor were re-elected as Sector Chair and Vice Chair, respectively.

→ National Textiles Independent Verification Exercise Kicks Off

The National Independent Textiles Verification Exercise, comprising textile experts and representatives from KRA, KEBS, MITI, KEPSA, and the KAM Secretariat, has kicked off. In preparation for this exercise, KAM circulated a questionnaire to all sector members for completion. The verification visits will cover key textile manufacturing regions including Mombasa, Nakuru, Eldoret, Central, and Nairobi. The findings from this exercise will inform the development of a comprehensive report with policy recommendations aimed at strengthening and enhancing the competitiveness of Kenya's textile sector.

Outcome

2. All textile sector members are required to fill in the KAM-issued questionnaire accurately.

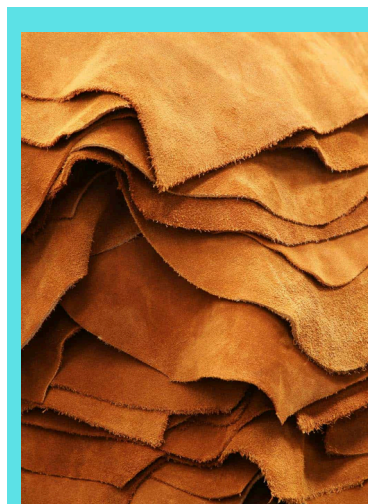

The engagement marked a significant step toward unlocking investment opportunities and addressing sector bottlenecks through strategic partnerships.

→Engagement with State Department for Industry



Engagement Details

On 18th March 2025, the stone-coated roofing tiles industry engaged the State Department for Industry to discuss challenges facing the industry and come up with a way forward.

Some of the areas of discussion include: having an EAC-wide DRS for inputs to manufacture stone-coated roofing tiles; potential misuse of DRS; validation of capacities available in the sector, and have verification to guide the tariff split on AZ steel coil, among others.

Outcome

Conduct a verification exercise to ascertain the capacities and potential split on tariff line 7210.61.00

The Ministry of Investments, Trade & Industry to support the proposal for an EAC wide DRS on stone coated roofing tiles inputs.

→Building, Mining and Construction Sector QI Meeting



Engagement Details

On 26th March 2025, the Building, Mining and Construction Sector held the quarter one sector meeting to discuss various issues affecting the sector and, in addition, come up with the priority advocacy areas for the sector.

Some of the key areas of discussion include reviving the discussion on affordable housing, having a sensitization workshop on the mining regulations and delineation of national and county government functions, support on the export markets, among others.

→ Flexible Packaging Sub-sector meeting



Engagement Details

On 7th March 2025, the Flexible Packaging Sub-sector held its Quarter one meeting to discuss the Sub-sector's outlook and priority areas for the industry. Members emphasized the need to hold a meeting with NEMA to discuss on the implementation of EPR Regulations and Plastic Packaging regulations.

Manufacturers also expressed concerns on the unit of measure to be charged per item. KAM Secretariat briefed members on excise duty discussions for articles of plastics & inks.

Outcome

KAM to convene a meeting with NEMA, State Department for Industry, State Department of Environment and KRA to discuss on the implementation of EPR, specifically charging the Ksh 150 per item.

→ Engagement with Kenya Invest Authority



Engagement Details

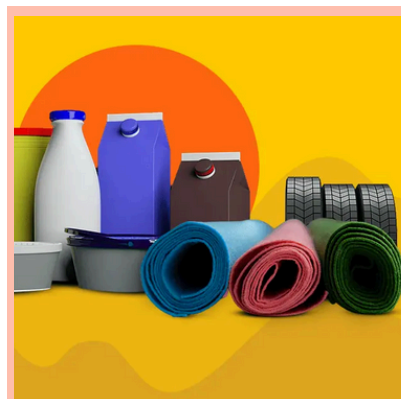
On 12th March 2025 KAM Secretariat engaged KenInvest and private sector stakeholders in the circular economy space to discuss EPR implementation challenges. Members noted the need to clarify the unit of measure to be applied in levying the Ksh 150 per item.

It was noted that there is a need for the government to involve manufacturers and private sector stakeholders in determining the unit of measure and provide a list of materials charged.

Outcome

KenInvest requested private sector stakeholders to review their proposals and develop a business case for Government.

→ Plastics & Rubber Sector Q1 Meeting



Engagement Details

On 27th March the Plastics & Rubber Sector held its quarterly meeting to discuss the sector outlook and status of issues for tracking. Key areas of priority for the sector include: addressing EPR implementation challenges; plastics packaging regulations; introduction of excise duty for printing inks, articles of plastics and resins used in manufacturing.

Members noted that the introduction of excise duty has increased the cost of finished products and making locally manufactured goods uncompetitive in the Kenyan market.

Outcome

1. Members requested for a follow-up meeting with SDI, NEMA, KRA and KENTRADE to discuss on the unit of measure charged on products as per the EPR Regulations.
2. KAM to convene a meeting with NEMA to discuss the challenges with implementation of EPR and Plastics Regulations.

Upcoming Activities:

1. Meeting on woven & Non-woven workshop on KNWA 2884:2019: Non-woven Polypropylene bags standard to be held in April 2025.
2. Meeting with SDI, KRA, KENTRADE and NEMA to discuss implementation of gazetted EPR regulations in April 2025.
3. Meeting with NEMA to discuss challenges on the implementation of gazetted Plastics regulations in April 2025

The meeting had participation from the manufacturing sector, importers and suppliers, building contractors and professionals, and the Competition Authority of Kenya.

Outcome

1. For those found violating KEBS standards, their license will be suspended.
2. Enforcement of standards will be done at the producer level and at the imported level.
3. KEBS will publish the names of violators in print media and explore prosecution.
4. The industry to continue providing intelligence on the existence of substandard products.

The meeting emphasized on the benefits of supporting Kensalt Kanagoni by including community representatives to the already existing CSR structure to coordinate community project requests.

Engagement Details

Outcome

Of particular concern were the Seawater Levy. The meeting agreed to form a collaborative working group to drive these initiatives forward. This group will focus on addressing the challenges identified and advancing strategies to enhance the sector's competitiveness and sustainability.

ENERGY, ELECTRICAL AND ELECTRONICS SECTOR

→ Transformer manufacturers Sub-sector meeting on Excise Duty



Engagement Details

On 18th March 2025 transformer manufacturers held a meeting to discuss on the Excise Duty (Amendment) Bill, 2025 removal of 25% excise duty on imported transformers and parts for tariffs. Manufacturers raised concerns on the increased importation and supply of transformers to government agencies which is against the government principles under the Buy Kenya Build Kenya. The sector recommended that local manufacturers be considered in energy infrastructure projects.

Outcome

Members objected the removal of excise duty on imported fully assembled electric transformers and proposed the removal of excise duty on parts to spur the growth of the industry.

Further, manufacturers proposed for multi-stakeholders meeting with PS Energy and utility firms to discuss local sourcing for transformers and the investment within the industry.

→ State of the Petroleum Industry QI Meeting



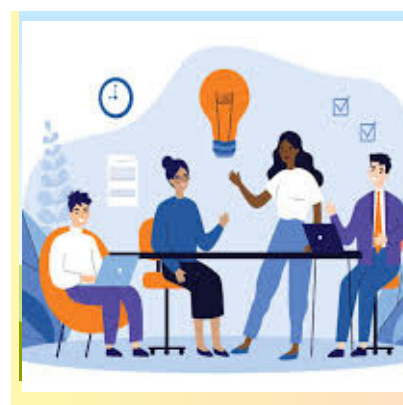
Engagement Details

On 25th March 2025 KAM Petroleum, Oil, Gas & lubricants sub-sector engaged the Cabinet Secretary MITI Lee Kinyanjui, EPRA and State Department for Petroleum for the state of the petroleum industry quarter one meeting. Members expressed the need to fast track regulations at the Attorney General's office, increased counterfeit and illicit trade and VAT refunds as the key challenges that continue to hamper the growth of the industry. The industry proposed for a revert to pre-shipment inspection as one of the approaches to mitigate impact of increased sub-standards.

Outcome

CS MITI committed to work with the industry in ensuring the issues on VAT refunds are resolved and engagement with KEBS to discuss on the pre-shipment vs destination inspection.

→ Energy ,Electrical & Electronics Sector QI Meeting



Engagement Details

On 27th March 2025, Energy, Electrical & Electronics Sector held a quarterly meeting to discuss on the sector priority issues and develop strategies and a matrix for the year. Key notable items discussed are increased trade and importation of substandard products, counterfeiting and illicit trade, high cost of production, finalization of electronics regulations, undertaking a verification for the petroleum industry, excise duty on transformers among others.

Outcome

KAM to convene meetings with the relevant government MDAs to discuss and address members concerns.

The paper sector to submit data on the status of local sourcing of packaging materials by the pharmaceutical sector. This will inform a joint meeting and next steps on applicable taxes and duties on packaging materials.


