

# TERMS OF REFERENCE FOR PREQUALIFICATION OF WASTE MANAGEMENT SERVICE PROVIDERS FOR (EPROK)

#### 1. About EPROK

The Electronic-waste Producer Responsibility Organization of Kenya, (EPROK) is a collective Producer Responsibility Organization established to drive sustainable management of electronic and electric waste in Kenya. It operates with the obligation to implement the Sustainable Waste Management Act of 2022 and its accompanying Regulations of 2024 on behalf of its members. EPROK supports manufacturers in addressing and managing waste generated from electric, electronic, and electrical equipment, fostering collective action within the industry.

Legally incorporated as a registered entity under Section 13 of the Companies Act, 2015, EPROK is structured as a company limited by guarantee and is governed by its articles of association. It provides essential services in post-consumer waste management and collection to its member companies, ensuring that environmental responsibilities are met efficiently and effectively.

As Kenya's first Producer Responsibility Organization specifically focused on electronic and electric waste, EPROK has established a strong presence and credibility. It boasts a membership base of over fifty organizations and offers broad representation across more than ten distinct waste streams categorized under electric and electronic classifications. Through its coordinated efforts, EPROK plays a pivotal role in advancing responsible e-waste management and compliance in Kenya.

#### 2. Background

The Electronic-Waste Producer Responsibility Organization of Kenya (EPROK) has been established to address the growing challenge of electronic waste (e-waste) in Kenya. E-waste refers to discarded electrical or electronic devices, and its improper disposal poses serious environmental and health risks. To mitigate this issue, EPROK aims to implement a comprehensive **Extended Producer Responsibility (EPR) Plan** that holds producers of electronic devices responsible for the collection, recycling, and disposal of their products after they reach the end of their life cycle.

The Extended Producer Responsibility Organisation of Kenya (EPROK) seeks to prequalify competent waste management service providers to implement its Extended Producer Responsibility (EPR) Plan in accordance with national environmental regulations and standards.



#### 3. Objectives

To prequalify service providers in the e-waste sector engaged in management, collection, aggregation, and transportation, establishing a roster of qualified waste management companies within the 47 counties. These providers must demonstrate the technical capacity, experience, and infrastructure required to efficiently collect, sort, transport, recycle, and dispose of waste materials in alignment with EPROK's Extended Producer Responsibility (EPR) Plan.

#### 4. Scope of Work

Prequalified service providers should demonstrate capability in one or more of the following areas of E-waste recovery Operations including:

- 1. Collection and aggregation of e-waste materials from designated points
- 2. Transportation of e-waste to processing facilities
- 3. Sorting and segregation of different e-waste streams
- 4. E- waste Recycling and recovery operations
- 5. Final Disposal of e-waste materials
- 6. E- waste Data collection, reporting, and traceability systems
- 7. Capacity building and awareness on environmental sustainability including ewaste.
- 8. Recognition from E-waste representative association, network and groups

#### 5. Application Procedure

#### 4.1 Technical Capacity

- Minimum 2 years of experience in waste management services
- Demonstrated expertise in handling E-waste & specific waste streams
- Adequate equipment and infrastructure (vehicles, storage facilities, etc.)
- Trained personnel and management team
- Quality control procedures and environmental management systems
