



→ KEBS technical committee meeting on food labelling

Engagement Details

Outcome



On the 4th-5th of August 2025, members of the Agro-processing and Food, & Beverage Sectors met the KEBS Technical Committee on Food Labeling to develop Kenya's position on the following standards: DEAS 38:2024, DEAS 1244:2024, DEAS 1245:2024, DEAS 1246:2024, and DEAS 1247:2024.

The purpose of the meeting was to ensure that the country's food labeling standards align with international best practices while safeguarding consumer interests and supporting the growth of local industries.

Kenya's position on the standards was finalized, and the submission was made to the EAC Technical Committee through the KEBS Technical Committee Secretary.

Kenya's submission, together with those from other EAC partner states, will be discussed during the EAC Technical Committee on Food Labeling scheduled for September 2025.



AUTOMOTIVE SECTOR

→Automotive industry Multi-sector Forum

Engagement Details

On 21st August 2025, the Automotive Sector Multi-Stakeholder Forum was held in collaboration with key policymakers. This high-level engagement brought together industry leaders and government representatives to deliberate on the challenges, opportunities, and future of Kenya's automotive sector. Key topics included regulatory reviews of Legal Notices 112 and 84, e-mobility, industry incentives, standards, and pending legislation, all aimed at strengthening industrialization, attracting investment, and creating jobs.

Outcome

The sector, through KAM, was tasked to prepare and submit a proposal on tax measures for inclusion in the Business Laws Act.

Engagement Details

On 4th August 2025, the leadership of the E-Mobility Sub-sector participated in the E-Mobility Sector Roundtable organized by the World Bank in collaboration with the Kenya Investment Authority. The primary objective of the meeting was to validate the revised E-Mobility Pitch Deck being developed by KenInvest. This strategic tool is designed to highlight the sector's opportunities, showcase key value propositions, and support investor engagement at both local and international levels.

TEXTILES & APPARELS SECTOR

→ EPZ Sub-sector inception meeting



Engagement Details

KAM is in the process of establishing an EPZ-Based Manufacturers Sub-Sector, bringing together members from across all the 14 KAM sectors. The inception meeting was held on 5th August 2025, during which Mr. Pankaj Bedi was elected as the interim Sub-Sector Chair. Key issues discussed included challenges facing EPZ-based manufacturers, the importance of encouraging EPZ members outside KAM to join the Association, and plans to organize a Sub-Sector engagement to foster interaction among members.

Outcome

It was agreed that:

- I.KAM will follow up with other EPZbased manufacturers to encourage them to join the Association as members.
- 2. A deep-dive analysis for the sub-sector will be developed.

→ Public Private Dialogue on AGOA



Engagement Details

KAM, through the IDH Project, held a PPD workshop on AGOA Extension from 12th August to 15th August 2025 in Naivasha, bringing together government agencies and stakeholders to align Kenya's advocacy strategy. Plan A focuses on securing AGOA's extension under current terms, emphasizing job creation, gender inclusivity, resilient supply chains, and stronger bilateral trade. Participants also discussed value chain integration for potential yarn-forward rules of origin. Plan B, a Kenya-U.S. FTA with preferential market access was identified as a fallback to safeguard jobs and exports.

Outcome

The agreed outcome was that the proposed way forward would be shared with the Ministry of Investment, Trade, and Industry (MITI) for adoption as the official industry position.

As a follow-up to the Denmark Learning Mission on Circularity and Extended Producer Responsibility (EPR) for the textile sector, held from 18th May to 23rd May 2025, participants convened for a feedback session to map the way forward in implementing the best practices acquired during the mission.

The team agreed to organize a workshop in Machakos in September 2025 to deliberate on the sector's EPR Strategy.

LEATHER & FOOTWEAR SECTOR

→ KAM Leather & Footwear Sector Meeting with KRA

Engagement Details

The KAM Leather & Footwear Sector met with KRA Customs on 13th August 2025 to address challenges affecting competitiveness, including illegal exports of raw hides and the influx of cheap and used footwear. KRA committed to strengthen monitoring, particularly on footwear valuation, while KAM will follow up with the DVS on the illegality of exporting ground-dried hides. institutions agreed to organize a sensitization forum for KRA border staff to enhance compliance.

Outcome

It was agreed that:

- I.KAM will follow up with the Directorate of Veterinary Services (DVS) to address the illegality of exporting ground-dried hides under Cap. 359.
- 2.KAM and KRA will organize a sensitization forum for all KRA border staff on leather sector issues to enhance compliance during exports and imports.

→ Leather & Footwear Sector Meeting with SDI

Engagement Details

On 5th August 2025, the KAM Leather & It was agreed that: Footwear Sector met with the State Department for Industry and Tanneries Association of Kenya (TAK) to discuss sector challenges, including limited access to raw materials and poor information flow between stakeholders and government. Key actions identified were enforcing Cap. 359(19) to curb illegal drying and smuggling of hides and ensuring food protocols are followed when exporting hides to West Africa.

Outcome

- I.A National Working Committee comprising all stakeholders in the leather industry would be constituted.
- 2. Cap. 359 would be enforced to address sector challenges.



Engagement Details

The National Leather & Leather Products It was agreed that the interim committee Platform was constituted, and its inception meeting was held on 19th August 2025, following up on a meeting with the State Department for Industry on 5th August 2025. The platform will serve as the main point of contact for leather industry matters in Kenya. Members agreed to develop and circulate a Terms of Reference (ToR) document to guide engagements. Interim leaders were elected, with Mr. Jimmy Odhiambo serving as Chair of the committee.

Glass Processors verification exercise

Engagement Details

KAM, in collaboration with the State It was agreed that the report has been Department for Industry, conducted a finalized and will now proceed for further verification exercise for all glass processors in the country from 11th to 13th August 2025. This exercise was necessitated by the Finance Act 2025, which introduced an excise duty of 35% or KSh 500 per m² on float glass. The Act, however, provides an exemption for processors who add value through the production of toughened, tempered, or laminated glass.

Outcome

Factory visit to Bamburi Cement

Engagement Details

On 15th August 2024, KAM conducted a factory visit to Bamburi Cement PLC, a member of the Pan-African business challenges facing the sub-sector, including conglomerate Amsons Group. The cement industry remains a key sub-sector of Kenya's economy. The visit aimed to gain a deeper understanding of the cement manufacturing landscape and to discuss challenges facing the sector, including high power costs, quality concerns, mining fees and levies, and county cess. The engagement also explored potential opportunities within the sector.

Outcome

It was agreed that KAM would actively and robustly advocate for the resolution of key regulatory, operational, and cost-related issues, to enhance competitiveness, sustainability, and growth within the cement industry.




PLASTICS AND RUBBER SECTOR

→ KAM & SDI factory visit to Aquosys Limited

Engagement Details

Outcome



On 12th August 2025, the KAM CEO and a representative from the State Department for Industry visited Aquosys Limited, a GRP water tank manufacturer serving the local and EAC markets. The visit highlighted the company's adoption of advanced manufacturing technologies while raising critical concerns on escalating production costs. Specifically, the 20% excise duty on resins introduced under the Tax Laws Amendment Act 2024, coupled with the 10% import duty under the EAC CET, has rendered the industry uncompetitive against cheaper imports from India and China.

It was agreed that:

- I.KAM and the State Department for Industry (SDI) will support the submission for the removal of excise duty under the Tax Laws Amendment Bill 2025.
- 2. Aquosys Limited will submit budget proposals requesting Duty Remission Scheme (DRS) on raw materials and inputs through the FY 2026/27 budget cycle.

→ EAC standards harmonization workshop

Engagement Details

KAM participated in the EAC Standards Harmonization Workshop led by KEBS to discuss member feedback on standards for plastic cups, household items, and water storage tanks. Following the adoption of the submitted feedback and comments, technical teams from EAC partner states reviewed and edited the draft standards text.

Outcome

It was agreed that KEBS, as the lead of Kenya's delegation, was to submit members' feedback and comments to the EAC Technical Teams. This ensured that Kenya's industry perspectives were effectively incorporated into the regional standards development process.

METAL AND ALLIED SECTOR

→ Fostering partnerships for the growth of Kenya's Aluminium Packaging Industry

Engagement Details

On 18th August 2024, KAM, under the Metal and Allied Sector, engaged GZI Limited, a subsidiary of Africa's leading packaging company. Discussions centered on access to raw materials, particularly food-grade aluminium alloyed coils, and the need to protect locally manufactured aluminium cans from import competition. GZI Limited has invested heavily in an aluminium beverage can plant in Sultan Hamud, highlighting the importance of supportive policies to enhance competitiveness.

Outcome

It was agreed that the KAM Metal and Allied Sector would fully support GZI Limited, and that KAM would engage relevant government agencies to participate in the official opening of the company's plant in October 2025.

From 25th to 29th August 2025, the East It was agreed that the final draft steel African Community (EAC) deliberated on key steel sector standards, including FDEAS 035/004/2025, 134:2025. WD/TC WDEAS/TC 035/005/2025, WDEAS/TC 035/001/2025, WD/TC 035/006/2025, WDEAS/TC 035/002:2025, and WD/TC 035/003/2025. These discussions were critical in aligning regional standards to ensure consistency, enhance product quality, and promote fair competition. The harmonization process is expected to boost intra-regional trade and strengthen investment in the steel industry.

→ Salt Sub-sector CSR Catchment Area Meeting


Engagement Details

→ Public consultation workshop on petroleum regulations

Engagement Details

On Thursday, 28th August 2025, KAM participated in the Public Consultation Workshop on Petroleum Regulations at Sarova Panafric Hotel, Nairobi, spearheaded by the Ministry of Energy and Petroleum and EPRA. The workshop gathered feedback from the public, civil society, and industry on the draft regulations, which aim to establish a framework for petroleum operations covering costing, environmental management, health and safety, local content, and land acquisition and restoration.

Outcome

Members were requested to submit their feedback on the draft petroleum regulations to EPRA by September 2025. This input will ensure that industry perspectives are incorporated into the final regulations, helping to create a balanced framework that supports sustainable petroleum operations, promotes safety and environmental compliance, and enhances local content and operational efficiency.

→ Public participation on the Draft Petroleum (Amendment) Bill 2025



Engagement Details

On Friday, 29th August 2025, KAM participated in the State Department for Petroleum's public consultation on the Draft Petroleum (Amendment) Bill 2025 at Sarova Panafric Hotel, Nairobi. The bill aims to address existing gaps by enhancing provisions on security of supply, setting standards for the construction of facilities, providing parking for distributors and trucks, regulating the transfer of permits and licenses, and establishing common-user facilities, with the Authority empowered to approve all tariffs charged.

Outcome

Members were requested to submit their feedback and formal submissions to the State Department of Petroleum by I2th September 2025. This will ensure that industry perspectives are fully incorporated into the Draft Petroleum (Amendment) Bill 2025, supporting a regulatory framework that is both practical and conducive to sustainable petroleum operations.

PAPER AND PAPER BOARD SECTOR

→ Publication of Revised Paper Sector Standards

Engagement Details

Outcome



The Paper Sector Technical Committees, through KEBS, have reviewed and finalized the following standards: KS 921:2025 Kenya Standard — Kraft Liner — Specification, Third Edition; KS 948:2025 Kenya Standard Corrugated Fibreboard Boxes for Export of Horticultural Produce — Specification, Third Edition; and KS EAS 355-1:2025 Kenya Standard — Toilet Paper — Specification, Part I: Regular Toilet Tissue Paper, Third Edition.

The finalized paper sector standards were officially published through a Gazette Notice dated 8th August 2025. Their publication provides legal recognition and ensures that manufacturers, exporters, and other stakeholders in the paper industry align with consistent quality and safety requirements, thereby strengthening competitiveness in both local international markets.

→ Engagement with KRA on influx of substandard tissues

Engagement Details

Outcome



On 7th August 2025, KAM held an engagement with KRA to address the influx of substandard tissue products. It was noted that a significant number of products in the market are non-compliant with KEBS standards and are being sold at unrealistically low prices.

KRA committed to tighten clearance protocols for tissue products to ensure compliance with KEBS standards. Additionally, it was agreed that KAM will convene a sensitization meeting with KRA officials to enhance their capacity in identifying and addressing substandard tissue products.

→ Submission of Post-Budget tax reform proposals for the Packaging Sector

→ Cosmetics Regulation Workshop

The Cosmetics Subsector has organized a three-day workshop to discuss the regulation of cosmetics. The workshop, funded through the subsector kitty contributed to by members, is scheduled to take place from 1st to 3rd October. It will bring together stakeholders from government, industry, and international players.

It was agreed that members would be invited to attend the three-day workshop on cosmetics regulation, aimed at fostering dialogue with government, industry, and international stakeholders to align on regulatory frameworks and strengthen the competitiveness of the subsector.

Several KEBS Technical Committee meetings were held in August to discuss standards for cosmetics and surface-active products. The national comments were consolidated and submitted to the EAC, pending harmonization meetings.

Standards on avocado oil, butternut oil, groundnut oil, cosmetic pencils, deodorants, and antiperspirants were successfully harmonized during the EAC meeting held in Arusha from 24th to 29th August 2025. Building on this progress, standards on surface actives are scheduled to be harmonized in Bujumbura in October 2025, with invitations already circulated to stakeholders.

→ Application of Excise Duty by Uganda on furniture originating from Kenya

The Kenyan delegation, led by Dr. Sing'oei Korir, Principal Secretary, Ministry of Foreign Affairs, held a bilateral meeting with Uganda to review progress in implementing key priority trade areas. One of the main issues discussed was Uganda's application of excise duty on furniture originating from Kenya.

The Republic of Uganda informed the meeting that the Excise Duty Act had been amended to grant national treatment to products originating from EAC Partner States, effective 1st July 2025.
